



Making our Mark on Future Mobility

DENSO in North America is committed to supporting and increasing diversity within the technology fields. To support these activities, DENSO is offering a **\$50,000** grant to a US-based public charity to support its efforts in this area.

Proposals are sought for projects that involve hands-on, interactive outreach in all areas of future mobility including Autonomy, Artificial Intelligence, Internet of Things (IoT), and/or Connected Services.

Proposals should be for activities that:

- provide hands-on experience;
- engage a diverse or underserved community;
- provide opportunities to be innovative in thinking and
- provide an environment for problem solving and team building

Eligibility

- To be eligible for grant funding, organizations must:
 - have been presenting programs for at least two years
 - have the equivalent of at least one full-time employee
 - have revenues of more than \$100,000
 - have an annual budget of less than \$2 million
 - have 501(c)3 status.

Guidelines/Requirements:

- A. Grant proposal should include each of the following:
 - Clear goal or objective to program and problem to be solved
 - An action plan including a timeline of activities with milestones and measurements
 - A clear explanation of how the activity contributes to supporting and/or improving diversity within the focus area
 - A complete estimated budget including a breakout of expenses for which this proposal seeks support
 - A copy of most recent Form 990 statement filed by organization, a list of staff and board members and an example of measurable results from previous activities

- B. All applications for the grant must be submitted via the online application found at: <http://www.densomedia-na.com/national-grants-process-form/> .

Restrictions:

- A. The grant funds cannot be used for:
 - a. unrestricted general operating expenses
 - b. endowment funds
 - c. scholarships
 - d. religious organizations or for religious purposes
 - e. fundraising activities or events
 - f. umbrella funding organizations that intend to distribute funds at their own discretion
 - g. political lobbying or legislative activities
 - h. individuals
